


Re-Opening Pasco County Schools

After seeking input from parents and staff, Pasco County Schools has announced the plan for ReOpening our schools in the fall. Parents have three options to choose from. The deadline for choosing among the three back-to-school options has been extended to **Wednesday, July 8, 2020**.

As we continue to push out more information so that parents can make informed choices, we understand the need for more time to explore the available options. We also understand that the circumstances related to COVID-19 have shifted significantly in the past few days, and that the implementation of any return-to-school options may continue to be modified before students and most staff return in August. If circumstances worsen, we will await direction from the Governor's Office regarding the possible closing of schools.

Traditional

Your student is a Rushe Raven, taking classes on campus while following social distancing and other safety protocols. Students follow our bell schedule (50 minutes per class) and have daily contacts with CSRMS teachers for each class.



mySchool Online

Engaging virtual learning, with a connection to enrolled school. Daily virtual interactions and lessons with teachers during the regularly scheduled school day. [Learn more...](#)

Your student is a Rushe Raven, taking courses through myLearning off campus. Students follow our bell schedule (50 minutes per class) and have daily contacts with CSRMS teachers for each class. Courses through mySchool Online will be built to ensure engagement and rigor match the traditional classroom setting. Student can transition back to the traditional classroom on campus, when appropriate without any interruption to their learning.



Virtual School

Online learning through our nationally-recognized Pasco eSchool, offering flexible scheduling supported by Pasco County teachers, and opportunities for acceleration and enrichment. A semester or year-long enrollment required for the full-time program.

Your student is a Pasco eSchool Ninja taking courses through myLearning off campus. Students have a flexible schedule and can work at their own pace. Students have access to Pasco eSchool teachers Monday-Friday via phone, email, IM, and text. Family provides computer and internet access and an adult who can partner with Pasco eSchool teachers by serving as the learning guide for the student. Student may transition back to campus at the end of the semester (January) or the following school year, when appropriate.
